Annex A: Rondine Courses

Content, Calendar, Location, and Deadline for applications

1 - Advanced skills for Senior Researchers

The intensive courses for senior researchers (e.g., lecturers, associates, and full professors) last up to ten days.

The courses are open to researchers of all the partners involved, with scholarships for a minimum of 10 to a maximum of 50 participants. In any case, the number of participants will be adjusted according to the availability of funds and accommodation.

The partner institutions mainly provide the teaching staff.

Should any 50 places available not be assigned to researchers from the partner institutions, the remaining places will be offered (without scholarship) to non-partner researchers.

Renowned experts may be invited to give lectures.

Gender equality has to be guaranteed.

Actions to ensure the participation of cultural minorities will be implemented rigorously.

One of the courses focuses on ***Security in Constitutional Systems***, examining the topic through a highly multidisciplinary lens. *Scholars and professionals from both public and private sectors contribute, addressing security issues from both theoretical and practical viewpoints. The course is organized around four key thematic areas: migration flows, data flows, and capital/financial flows. Each of these areas is analyzed with a comparative approach, allowing participants to explore how different constitutional systems respond to contemporary security challenges across borders.*

The other course focuses on ***Constitutional Crises within Legal Systems***, particularly on threats or breakdowns in domestic legal orders. *It adopts a highly multidisciplinary approach, with both scholars and practitioners (from public and private sectors) addressing the issue from theoretical and practical perspectives. The course explores four key areas: constitutional violations and conflicts between branches of government; national security and international obligations; minority rights; and anti-discrimination law, all with a comparative perspective.*

At the end of the course, teaching staff and those participants who asked for a Research grant are required to submit an essay intended for publication as a condition for the payment of the final balance of the mobility grant.

Summer School on Security for Senior Researchers:

Summer School on Constitutional Crisis for Senior Researchers:

- **September/October 2025:** up to 10 days in **Milan Bicocca**, plus an additional possible max 5 days in Rondine Cittadella della Pace (see *Call Rondine Courses*);
- **deadline** for applications: **May 31, 2025**

The courses will only take place if a minimum of 10 participants is reached.

The courses are open to researchers of all the partners involved, with scholarships for a minimum of 10 to a maximum of 50 participants. In any case, the number of participants will be adjusted according to the availability of funds and accommodation.

The partner institutions mainly provide the teaching staff.

Should any 50 places available not be assigned to researchers from the partner institutions, the remaining places will be offered (without scholarship) to non-partner researchers.

Renowned experts may be invited to give lectures.

Gender equality has to be guaranteed.

The workshop focuses on **Security and Constitutional Crises in Contemporary Constitutional Systems**, offering a multidisciplinary approach to these pressing issues. *Experts from academia and practitioners from both the public and private sectors come together to explore the topic from both theoretical and practical perspectives. By bridging scholarly insights with real-world experiences, the workshop provides a comprehensive understanding of how contemporary constitutional systems navigate and respond to security challenges and crises. The discussions are designed to foster a deeper engagement with how legal frameworks and institutions handle threats to stability, highlighting the evolving nature of these issues in a global context.*

At the end of the course, teaching staff and those participants who asked for a Research grant are required to submit an essay intended for publication as a condition for the payment of the final balance of the mobility grant.
